The two companies will offer an integrated service, covering both land and sea, to support the ecological transition. Their ambition is to offer solutions based on a global perspective on all environmental issues, for urban, energy, agricultural, industrial and tourism projects. This expertise will also serve to strengthen the existing environmental engineering capabilities of setec's projects.

Specialising in marine biodiversity and environmental assessment for major coastal and industrial projects, *setec énergie environnement* has been supporting public and private stakeholders in their ecological and energy transition strategies for over forty years.

Encis Environnement is a major provider of environmental assessments for photovoltaic and onshore wind energy projects. The company is renowned for providing services in the fields of terrestrial biodiversity, landscape, water and agronomy, renewable energies and the regulatory environment. The company has 20 years of experience and strong regional presence, with more than 110 employees across eight regional offices.

The merger between setec énergie environnement and Encis environnement establishes the new entity as a key figure in supporting ecological transition. The transaction takes the form of a 53% acquisition of Encis environnement by setec énergie environnement, with the existing partners maintaining the remaining 47%.

Their combined scope includes more than 50 environmental project managers, 80 biologists, 20 landscape designers and computer graphic specialists, 50 waste and circular economy specialists, and 50 renewable energy experts.
